Statement of the Issue: The members of the Education and Technology Committee recommend changes to the purpose statement for the committee.

Rational for Proposal: The members of the Education and Technology Committee have modified the purpose statement for the committee in order to provide more clarity and for the purpose of updating content to align with current instructional technology-use.
