## Arkansas State University Staff Senate Meeting November 19, 2014

The Arkansas State University Staff Senate met on Wednesday, November 19<sup>th</sup>, 2014, in the Boardroom, 8<sup>th</sup> Floor of Library on the ASU-Jonesboro campus. Staff Senate Vice President, Randall Tate called the meeting to order at 2:03 p.m.

In attendance: Talvickeo Banks, Paula Broadway, Steven Brown, Jon Carvell, Anthony Coleman, Jeannie Cossey, Ellena Cox, Tonya Crittenden, Debbie Davis, Rodney Davis, Rebecca Craig proxy for Kasey Eakins, Vera Forest, Loretta Fulton, Brandy Hampton, Terry Locke, Carla McCain, Jennifer Novalick, Hope Phillips, Carolyn Ponce, Randall Tate, Nikki Turner, Elizabeth Wakefield and Debra Wright.

#### **October Minutes:**

Minutes were approved; motion made by Elizabeth Wakefield to accept minutes, second by Jon Carvell.

#### **October Treasury:**

Treasury report presented by Nikki Turner. The only notable change was for the P-card purchase of caramels for Santa's wolves.

#### **New Business:**

- a. Affirmative Action Alexia Whitaker updated Staff Senate in regards to self-reporting disability and veteran status. An email will be sent out to the campus later this month providing additional information on this process and why it is needed. Alexia would like our help in getting the word out to our constituents. She provided handouts with bullet points as to why this is needed, and for us to pass along if there are any questions we receive from other staff members. She mentioned one of the reasons the disability status was needed, was to know where assistance would be needed in the case of an emergency. Jon Carvell also addressed emergency exit assistance. Any persons that do not want to disclose their disability status can voluntarily contact him directly. Alexia mentioned that the invitation to disclose their status is to help the individual and is kept confidential.
- b. Educational Stipend Loretta Fulton, Brandy Hampton, Anthony Coleman, and Elizabeth Wakefield (past recipient) will serve as committee members. Nikki Turner spoke on details of past award recipient numbers and amounts of stipends. New extended deadline to be posted on Digest. Talvickeo Banks will work with committee to get the online form updated.
- c. Election Committee Randall Tate, Brandy Hampton and Tonya Crittenden will serve as committee members. Open discussion lead by Randall Tate. Tentative dates of process were passed around and details of items were discussed with senators. A mixer is being added this year for the incoming senators to meet existing senators, and new senators will be invited sit in on a meeting prior to the start of their term. Loretta Fulton asked for a listing of when current senators would roll off. Randall will provide that list at the January meeting, and mentioned that the senators and their term listings might be listed on our website.

#### **Old Business:**

- a. Distinguished Staff service award plaque Mark Reeves and Gibson Sign Mart estimated a cost of \$2,000 for the additional 100 names, which comes out to \$20 per name. If approved, Angela Daniels will appoint an ad-hoc committee of adding five staff members every five years. Terry Locke thought it was money that could be better used elsewhere. Currently there is additional funding in the Santa's Wolves account to cover the cost. Hope Phillips mentioned that it would be nice gesture to do it every five years instead of every one hundred years. Rodney Davis thought it was a good idea as well, as other universities honor their faculty and staff in similar ways. Hope Phillips made a motion to proceed, Rodney Davis seconded.
- b. Constitution and Bylaws Open discussion on proposed changes to Staff Senate constitution and bylaws. Carolyn Ponce asked for clarification on reelection of senators who filled a vacancy. To keep rotations in order, the filled position will serve the remaining term, and the position will be permanently filled in the next regular election. The appointed representative may stand for election at that time. Motion approved by all senators. The changes will be forwarded to the Chancellor, who has final say.

- a. Nikki Turner asked for discussion on the December meeting. Ron Carvell suggested if there were any urgent meeting issues for December we could discuss via email if possible. Randal Tate motioned to cancel December's meeting. Talvickeo Banks seconded.

- c. Jeannie Cossey asked if Santa's Wolves committee needed any volunteers to help. There were no committee members at the meeting, but Elizabeth Wakefield mentioned that the majority of the time the names are split out by committee members and they purchase the items.
- d. Lori Winn reminded the group that open enrollment closes on Friday. She asked for us to remind our constituents of this deadline.
- e. The next meeting date is scheduled for January 21st in the Library Boardroom.
- f. Motion to adjourn was made by Hope Phillips at 2:21; second made by Rodney Davis.
